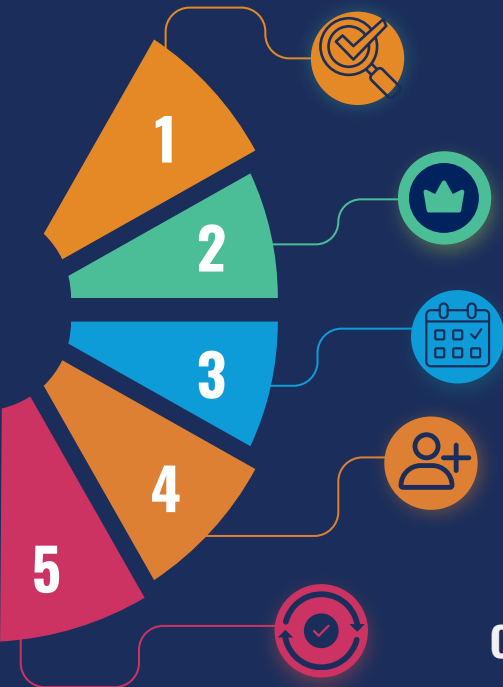

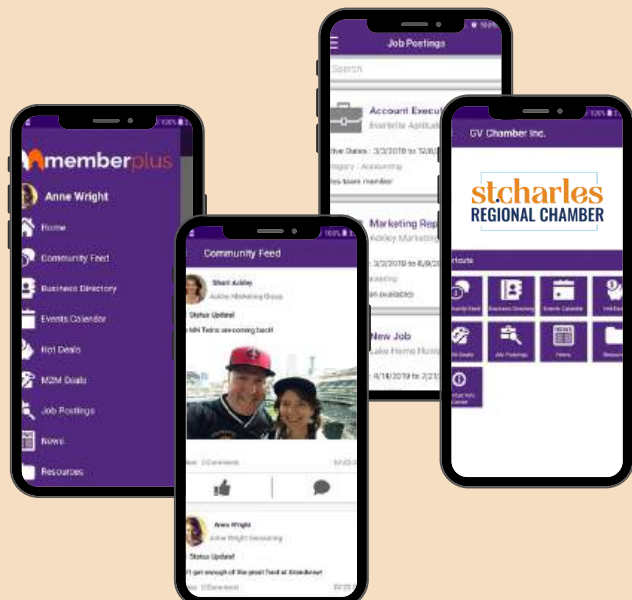

2026 LEGISLATIVE PRIORITIES

As a business owner, your success is directly tied to the policies that govern our state. At the St. Charles Regional Chamber, we believe in empowering our members to flourish, and a key part of that is through impactful advocacy.

Our 2026 Legislative Agenda is a direct result of our Coalition Policy Summit, where members and business leaders worked together to define the most critical issues affecting our region. When you are part of the Chamber, you are part of a powerful voice that represents your interests to our State and Federal Representatives.

OUR 5 KEY PRIORITIES

WORKFORCE DEVELOPMENT

We support targeted childcare tax credits to help working parents, expanding the Missouri A+ program to include industry-recognized certifications, and Clean slate Missouri to help low-level, non-violent offenders rejoin the workforce.

EDUCATION

Your business needs a strong local school system to thrive. That's why we oppose a statewide Open Enrollment policy that would create a significant funding shortfall for St. Charles County schools, harming the quality of education and the future workforce in our region.

TRANSPORTATION & INFRASTRUCTURE

A strong business climate depends on reliable infrastructure. We support sustainable funding for MoDOT to invest in our roads and bridges, including the widening of HWY N and improvements to HWYs K, 79, 61, and 364. We also support funding for public transportation opportunities in St. Charles County.

ATTAINABLE HOUSING

Supporting an increase in the recording-fee allocation from real estate transactions is a priority for us, with the goal of bolstering the Missouri Housing Trust Fund (MHTF). By directing more resources to the MHTF, we are fostering a housing landscape that is affordable and accessible.

SMALL BUSINESS & ECONOMIC DEVELOPMENT

We stand firm in that any changes to property tax must be accompanied by a reliable alternative funding source to ensure essential services like schools and public safety are fully funded. We also oppose the proposed constitutional amendment for statewide paid sick leave.
